Presentation on Bike Lanes for Freeport Blvd Caroline Peck, LP resident	Caroline did a PowerPoint Presentation proposing a Road Diet on Freeport between Taylor's Market and Sutterville. The proposal focuses on lane reduction to one lane in each direction with a center turn lane in the middle plus bike lanes going both directions. Primary issue is the need for improvement to accommodate bikes and pedestrians and increase safety. McClatchy High School and Sac. City College have large numbers of students using this section of Freeport. The proposed change should carry more or the same level of traffic because of the steady flow and center lane for turning.	Board listened to the proposal but did not provide a formal endorsement.
