

# Minutes Land Park Community Association Board Only Meeting

Eskaton Monroe Lodge, Game Room 3225 Freeport Blvd June 20, 2018 - 6:30 p.m. -8:30pm

Board Members present: Stephanie Duncan- President, Mitch Rohrer- Treasurer, Shannel LaDue, Joleen Lonigan, Craig Rutledge, John Schade, Art Taylor, and Steve Winlock. Absent: Alison Leary- VP

#### 6:34pm Call to order

- A. New board appointments- Bill Pavao, Denny Jones, Paul Parmley Denny Jones & Paul Parmley introduced themselves to the board. Bill Pavao was also present and has decided not to pursue a board seat due to other commitments. Motion to appoint Denny and Paul to the LPCA board made by Craig, seconded by John. Approved by 7 members of the board, Art Taylor abstained.
- B. PG&E Gas Line Replacement Update (Sean Valdez, Gas Outreach Specialist) Sean Valdez, Justin Besotes from Teichert, and Owen Flynn from Engineering Solutions were present with additional staff to share about latest phase of the project. The Pre-1940s pipes may have more of a tendency for leaks, so they are being replaced. Teichert is the contractor for the project. PG&E will be canvasing the neighborhood on Wednesdays and Fridays from 1-4pm to look at gas meter locations and mark with a yellow "whisker" flag.

  There will be holes made in the street and some areas will have trenches covered with metal plates. The area affected is Perkins Way and north of that area.

Meters will be moved to areas where maintenance and safety are considered. A slurry seal is coming to the area roadways in 2019. So far, PG&E has sent notifications to 1,500 people. Letters were sent at the end of May. They also have an interactive voice recording to landlines. Gas line replacement project for this area will be done before December 31, 2018. Restoration of roadways may not be completed by the end of the year.

- D. A Taste of Land Park Recap (Craig & Tommy)- Still tabulating all expenses and there will be an exclusive Taste meeting in the near future. It was requested by Stephanie that the 2019 Taste planning start ASAP and not wait until January. A

- E. Holiday Party (Shannel)- The absence of Holy Spirit last year did affect attendance. Looking at various options for this year's event including whether this can be an event where volunteers can serve Eskaton residents lunch.
- F. Committee Chairs & Secretary- No board members volunteered to be Chairs for Land Use or Parks or be Secretary.
- G. Movie in the Park & William Land Park 100<sup>th</sup>- Friday, August 3
  Event is being coordinated by Pinki Cockrell, former LPCA board member and current member of Land Park Volunteer Corps. Event will begin at 5pm and include performance by Sacramento Philharmonic, cake cutting, possible car show, and a 100-year-old resident of the area. Then, Movie in the Park featuring "Coco" will be shown at sundown. Front Street Animal Shelter will also be collecting donations. Vice Mayor Hansen's office will offer free water and popcorn during movie.
- H. William Land Park Tree Replacement (Mitch)- The area has an aging canopy that is 20 years behind schedule in plantings. The goal is to have 50 trees planted in the next planting season. The William Land Park sprinkler system is antiquated and needs replacement. One idea is to have an arborist visit LPCA meeting in the future to discuss trees in Land Park.
- I. Parks- Golf Course & Waterfowl (Stephanie)
  - -The City voted to allow Morton Golf LLC to take over the management of the William Land Park Golf Course from First Tee. First Tee decided to step away from managing the course due to financial losses. Stephanie spoke before the City Council to remind them of the other maintenance needs that William Land Park has had for years and not to forget about those in the midst of assisting Morton Golf with the transition and the City taking on some of the financial burden of the Golf Course. Other maintenance issues the park has are: Needs a new sprinkler system, reforestation plan, and park bathrooms need replacement/renovation. We have 1 new restroom only because there was arson 2 years ago.
  - -Boat Lake water levels in William Land Park have been low and causing issues for the waterfowl, particularly ducklings and goslings who cannot get out due to a cement lip around the lake's edge vs. a gradual slope into the lake. Judy McClaver aka Lady of the Lake has assisted in relocating 5 ducks. It is believed some ducks have been pets that were dumped in the park. At least one had its wings clipped, preventing flight and indicating it was a pet. These ducks were at risk because they were too friendly with people and dogs. Recent incident with off-leash dog that jumped into Boat Lake to chase waterfowl. Judy helped remove ducks from Boat Lake and the LPCA Parks Committee is providing funding to get them blood tests, vet care, and transportation to new home. One duck was rehomed in Sacramento and four others were to be transported to a sanctuary in Oregon.
  - -LPCA has requested that Parks install ramps for waterfowl to easily get in and out of Boat Lake until they can fix water level issue. Issue caused by float malfunctioning.
- J. LPCA taking a stance on:
  - 1. Airbnb Conditional Use Permits for year-round rentals

- -4<sup>th</sup> Ave Airbnb short-term vacation rental has applied for a conditional use permit to be used as a vacation rental year-round vs. 90-days per year allowed by City ordinance. Numerous neighbors to this rental have contacted the LPCA for assistance is preventing this conditional use permit from being approved. Residents complain of regular parties, lack of respect by Airbnb renters, garbage bins not being put out or brought back in per City code, loud music or people talking, smoking, laughing late at night or in early morning hours, and driveways blocked or street parking taken up by large numbers of people at the residence. The Airbnb owner has rules against parties, smoking, etc. that are not being enforced.
- -Board discussed vacation rentals within LPCA boundaries. Concerns included that vacation rental users are not supporting the neighborhood, such as schools, neighborhood restaurants, etc. on a regular basis. If rental control ordinance is passed, we could see even more people turning their extra homes into vacation rentals.
- -Since we are in a residential neighborhood, we desire to have residents, whether homeowners or renters on a lease, not short-term renters.
- -Part of LPCA mission statement is to protect and preserve the quality of life we enjoy in Land Park. That includes keeping it a strictly residential neighborhood, not have short term rental businesses.
- -LPCA Board voted against any conditional use permits for vacation rentals within LPCA boundaries. Board does not believe vacation rentals are beneficial to the neighborhood, but only to property owner who is financially profiting. LPCA mission statement includes protecting and preserving the quality of life we enjoy in Land Park. Will also request feedback from LPCA members before writing any letters to the City.
- 2. Del Rio Trail support and Excursion Train opposition
- -In 2015, the LPCA wrote a letter of support for Del Rio Trail. LPCA has been asked to update the letter by Del Rio Trail committee.
- -Should the LPCA write an updated letter of support for the Del Rio Trail? Motion made by Mitch, seconded by Steve. Craig abstained. Motion passed to write updated letter of support for Del Rio Trail.
- 3. Marijuana Dispensaries and cultivation permits- tabled
- 4. Homeless shelter in the Land Park area- tabled for now. Map provided showing City owned land, which are primarily sides of hills. One site is at Dooley Field, behind Holy Spirit School and where the Land Park Little Leagues plays baseball. It is not believed to be likely that the City will put a homeless "spring structure" tent on the sites within the LPCA boundaries.

#### K. Other Business

a. Membership BBQ will be held on October 7<sup>th</sup> from 3-5pm in William Land Park. Joleen is organizing event, which will include food, games, and music.

## 2018 Gas Pipeline Replacement Project

PG&E and our contractor, Teichert, will replace roughly 16,500 ft. of distribution gas main and 465 services in the Land Park Community (streets below). This work is expected to begin the week of June 25th and continue through the end of the year. Teichert will have plumbing contractors Fletcher's and Brower Mechanical install houseline plumbing to homes where meters will be relocated to the front of the home.

- Perkins, Weller, Govan, Marian, Robertson, Regina, Vallejo, Fremont, and Markham Ways
- 7<sup>th</sup>, 3<sup>rd</sup> Avenues
- 12<sup>th</sup>, 13<sup>th</sup>, and 14<sup>th</sup> Streets
- Swanston and Land Park Drives
- Riverside Boulevard
